It is clear to us that after 72 hours (three days) 10% in the memory of the listener who received the information by hearing, 20% by sight, 50% by sight and hearing, 70% in sight and hearing perception and discussion , 90% of the card can be memorized when using visual and auditory perception and practical opportunities in discussion. The style of teaching in this area is also very important. It was found that 5% of explanations are given in lectures, 10% in books, 20% in videos, 75% in games and problem-based learning, and 90% in teaching others.

The above methods may not always be justified. This is because the teacher must be able to choose the appropriate method, taking into account the psychological and other characteristics of the students. These methods show that it is a joint effort of teacher and students. Therefore, it requires coordination, control and encouragement.
