Social Life During the Anushteginid Dynasty. Social Protection and Population Appeals.

Abstract: This article discusses social life during the Anushtegin dynasty, which played an important role in the history of the Uzbek people and statehood. It analyzes the social protection of the population of that time, the appeals of the population, and the policies and role of the rulers of the dynasty in this system, mainly in sources, literature, and historical documents.

Social protection. During the Anushtegin dynasty, the state naturally tried to maintain the safety and well-being of the population. All devans and officials, except for devani essay, were strongly emphasized to work in this direction. The policies pursued by the rulers also include numerous processes related to the social protection and encouragement of the population. They include events ranging from the issue of endowments to the exemption from taxes and the distribution of grain to the people suffering as a result of disasters. During the reign of Sultan Takash, in the decree on the appointment of the chief judge of the country, in addition to the provision of Sharia justice, the issue of waqf was also mentioned. According to it, the responsibility of mosques and madrassas will be assigned to Sayfulmilla Kholafal Makkii, who was appointed as the chief judge. It is instructed to monitor the proper management of waqfs in the hands of appointed persons and deputies, and to give regular reports to the chief diwan, diwani ala. The chief judge of the country is also ordered to prepare a deputy, deputy, and a representative with full authority for all areas under his jurisdiction, who can be a guarantor for all landowners, crops, and agricultural work, in addition to matters related to mosques, madrasas, and endowments. The representatives are also asked to help the needy, identify them, and sacrifice their lives for their well-being 1.

Although taxes contradict the social protection system, it can be seen from many measures and documents carried out during this period that the social status of the population was taken into account in the levies levied on them. For example, in the document on the appointment of the country's chief financier (retired head of the department), it is ordered that the tax collected from the population be determined taking into account the state of the people and the prosperity and well-being of the society². In another similar document, it can be seen that the taxes collected from the harvest must be spent on improving the conditions of the needy, especially the poor, in order to achieve the pleasure of Allah³.

Living in the economy and the abundance of the Salbi population has an impact on the environment, leading to numerous natural disasters. During the reign of the Anushtega's dynasty, disasters befell both the population of Kulyab and the inhabitants of put. For example, how (1199-1200) yilda Marv and the surroundings of Nishapur led to great tension on the banks of the Bergan River in Yale Bay. At the same time, he said, he was killed in an accident that killed a man. The minister Sharafiddin Mohammed Ibn Salih, the ruler of command, with knowledge, was forced to abandon the products of his population⁴. Sultan Alauddin Muhammad also helped destroy the city of Butunlay during the reign of Nishapur⁵.

In the 1220s and 1224s, during the reign of Davlat I, Otabek Bek was forced to renounce his claims to the Gurja throne.
